**TOURNAMENT DATE:** March 12-15, 2009

**TOURNAMENT LOCATION:** Giammalva Racquet Club – 16400 Sir William Drive, Spring, TX 77379 (281-370-5801)

**ENTRY REQUIREMENTS - PRIMARY PLAYER:** The first player from a household who is an oil industry employee without regard to gender (Fee = \$185). The PRIMARY PLAYER is entitled to invite a playing Spouse or Guest to play in MIXED DOUBLES for an additional fee of \$60 and/or Women's Doubles for an additional fee of \$35 (**two events only**). A fee of \$35 will be charged for a non-playing spouse or guest. The PRIMARY PLAYER will be listed in the program with Company Name, and receive the full player ditty bag.

**TOURNAMENT PLAY:**

WOMEN'S DOUBLES: Play will begin Thursday evening at 6:00PM during registration. Divisions will be "A", "B" and "C" with a round robin format. Playoffs will take place Friday beginning at 6:00PM.

PRIMARY PLAYER'S DOUBLES: Play will begin at 8:00AM Friday March 13, 2009. This event will include four divisions: "Championship", "A", "B" and "C". Three matches are guaranteed.

MIXED DOUBLES: Play will begin Friday afternoon March 13, 2009. This event will include the same four divisions as the Men's Doubles. Teams will be ranked according to the male player's ranking. Two matches are guaranteed.
